High Melt Strength Copolymer for Extrusion Blow Molding

Product Description

Polyclear[®] EBM PET 5505 is a co-polyester with high melt strength designed for extrusion blow molding and suited to produce clear, high-gloss containers with and without handles that can be recycled with clear PET.

Polyclear[®] EBM PET 5505 is a true semi-crystalline PET polymer that exhibits high melt strength and slow crystallization to allow for processing on typical extrusion blow molding equipment when adapted for handling PET. Polyclear[®] EBM PET 5505 exhibits a typical T_G and a high melt point and processes similar to standard PET. Therefore, containers made from Polyclear[®] EBM PET 5505 can carry the resin identification code "PETE 1".

In addition, containers made from Polyclear® EBM PET 5505 can be recycled with the clear PET stream. Auriga Polymers Inc. has obtained a letter of recognition from the Association of Plastic Recyclers (APR) stating that Polyclear® EBM PET 5505 meets or exceeds the critical guidance requirements for recycling with clear PET.

High-gloss, clear containers made from Polyclear[®] EBM PET via extrusion blow molding are ideal for packaging juice, sports drinks, tea, edible oil, household cleaners, detergents, chemicals and automotive products and can replace containers made from other materials for extrusion blow molding such as PETG, PVC, PP, PC and HDPE.

Polyclear® EBM PET 5505 complies with the Federal Food, Drug, and Cosmetic Act for all food packaging applications and certain processing conditions. Letters detailing specific FDA clearances are available upon request from Auriga Polymers Inc.
